II. Opposing Testimony:

The following testimony will be in direct opposition to the accusations – by various judge in the Travis County Civil District Courts – that I am “Insane” – and which goes against my own Doctor (Kyle Vincent’s) testimony. III. Request Testimony for General Testimony:

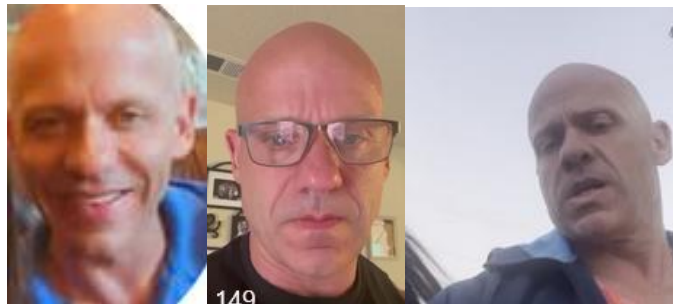
I will request testimony from the following people, & if they do not show I will thus subpoena them for my Motion for General Testimony – and if they are too far away to be subpoenaed, I will request they provide an Affidavit about their various crimes and extreme stupidity (AKA: insanity):



Patrick Wanker (self-identified: high-ranking Aryan Brotherhood gang leader), who showed his wedding ring figure tattoo to me – that meant he’s married to that gang. He also called African Americans the “N” word in private. Now, this man called the police and attempted to get me arrested – demonstrating that he is, in fact a “Rat.” I also sexually harassed this man – in an egregious manner – and he never did anything.

Chris Lee, owner of Grizzle Engineering, living around the Dallas, Texas area, who is another disgraced ex-member of the military – who has embraced the qualities of women, and allowed foreign nations to invade our southern border – and has chosen to be a gangbanger – rather than a law-abiding citizen. He stole \$8,000 from me, and fired me from a project in Indiana, because I wanted transparency in our conversations. He wanted to call me – to threaten me – and I asked him to threaten me in a text message. He also directed several workers at his company, harass me – I am assuming because I used my right – to Free Speech – when criticizing a member of the military – that embezzled, slept with his employee’s wives, among other misconduct.

**And because this man spoke at length about how men should feel shame about things – I would like for him to provide testimony about the complete pussification of our Military – considering when I was on-base in Great Lakes, I was told that there were so many orgies going on – and everyone was having so much sex – that the barracks had to be separated – between the sexes. And I would also like for him to discuss with the court – his feelings – and why he believes, he allowed the US to be invaded. And if, the lowering of disciplinary standards – and the extremes of training – so women can compete with guys – has anything to do with the “Pussification.”



Rick Hightower (Freemason Operator – associate of Susan Hightower Federal Judge and General over the Aryan Brotherhood), who Patrick Wanker insinuated was a Low-Level Project Artichoke operative – that abuses infants, toddlers and children, to influence them, manipulate them – to commit any number of crimes – not limited to school shootings. 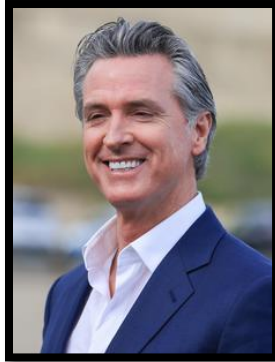

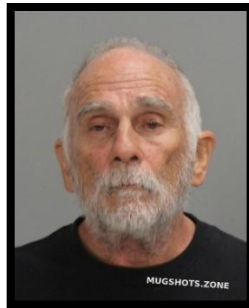

Including: +60-year-old inmate – Mr. Ervin – in Bastrop County Jail (pod 12-A – in June 2023) with swastikas on his upper body (which means he’s a General in the Aryan-Nazis Army) and only his own family members were in that ail pod. This group – whom I had a conflict with, from 2009 to 2013 – which began when Tim Ervin explained to me that to rise the corporate ladder I would have to be racist – and call African Americans the “N” word, and in 2013, Brad Ervin, then President of Ervin Cable, called me on the phone to tell me, I tricked him into calling the FBI, on his own company – and he was forced to feed the FBI all kinds of information about their crimes. As retaliation, they conspired with their connections in the Masons and Aryan-Nazis Brotherhood – to feed me into the judicial system – and thus into the penal system – and into Mr. Ervin’s high security jail pod – after endless crimes were committed against me in the judicial system. These men – consider themselves very high-level gangsters – but I’m not too sure. I think they lost a lot of credit in the Aryan-Nazi-Mason Brotherhood.

Note: I actually like these guys – and enjoyed working with them, regardless of all the crimes and scams they ran on me, like the villains in those Scooby Doo cartoons.



Ethan Graham, of College Station, Texas, a low-level sorority-Mason, that endlessly harasses employees at Entrust Solutions – in the name of Jesus – and whom grabbed me – in an apparent sexual nature – which could be identified as a sexual assault – in the parking lot of a restaurant, after church – which leads me to believe – he is in fact – a homosexual-Christian.

Jim Alexander (a low-level sorority-Mason) who – in fact – has never done anything in his entire career other than annoy everyone – and grow fat – while working at Ervin Cable Construction LLC, and he calls that, “Work.” He has – in fact worked – a “Sit-in-chair-and-talk-job” his entire life.



Sherita Lynch (lawyer Ad Litem) that committed endless crimes against me, after stealing \$2,000 – she refused to follow court orders – filed a false police report in an attempt to get me arrested – that was recognized as false by Cedar Park Police, then provided perjured testimony on June 8th 2023 – that was proven perjured by the afore mentioned false police report. Note: She couldn't even get the color of my truck correct in her police report. I was black not silver. Then, she was allowed to file a second police report – using an illegal Act of Congress – the Patriot Act – to get me arrested, for simply using Free Speech – to argue with her, about her various crimes against me. She also said over the phone, that my son was being turned into a girl – then attempted to censure my court case – to hide her various crimes – so I published all the important court documents in a book, in the Public Domain.

This woman – when she sabotaged my case – I'm pretty sure is a single parent – raising children alone – without a father – believed in abortion, and said I shouldn't see my son, because I spoke about abortion. She also mention a Federal court case – I had – and posted on my social media – as reasons my son should be taken away.

Ron Lord, of Fredericksburg, Virginia, whom endlessly harassed me at work, at Entrust Solutions – and would scream at me in meetings, discussing my personal life in front of other employees – he also identified himself as knowing many high-ranking Masons, and could explain a great deal about their scams and activities. He also had a young mother 20 something girl – “Train” – at his house, for a great deal of time – when normal procedure was for trainees to work remotely, from home. Then, he made his “Trainee” the manager, over men that had worked in the field for decades.



Vicente Carvalho, of the Orlando area – will testify as to his true opinion of Americans – and how much better than Americans – he is...Which will be a demonstration as to how much of an idiot he – in fact – is...He secretly hates Americans – and has told me so – as a form of disrespect – knowing I was an American. He's told me – that US Citizens – shouldn't call themselves “Americans” and that we couldn't run our country – without people like him. As further idiocy of this man he will be asked to testify about his comments – that he is a high-level martial artists – but was abused by his parents when they didn't take him to Disney World as a child.



Eduardo Martinez, of the Sacramento, California area – will give testimony as to why Mexico should take control of the USA – especially California – even though Mexico as a nation – never endeavored to fight in a conflict – neither WWI, nor WWII, nor have they even tried to formulate morality in their country – and their nation still – to this very day – practices slavery in its classic form. I have literally spoken to men and women – Mexicans – that claim that they were slaves – in Mexico.
