# REPORT: OPERATION Of & CRIMINAL ELEMENT (DOMESTIC TERRORISM ACTIVITY) WITHIN COMPANY

The Following Report has been filed in the Courts – to become a Legal Document (an Instrument of The Law) & has been sent to: The Pentagon, various Law Enforcement Agencies in the country, and the FBI...

## Of Note:

Many of our ex-service members are a complete disgrace, and they've decided to operate within the Deep State as Domestic Terrorists against Americans, and also, against our US Constitution, shirking their Oath of Service, "to defend," the US Constitution (of note: The First Amendment being Free Speech)...

#### **REMINDERS:**

#### US Service Member's Oath of Service:

I, \_\_\_\_\_, do solemnly swear that I will support and defend the Constitution of the United States against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; and that I will obey the orders of the President of the United States and the orders of the officers appointed over me, according to regulations and the Uniform Code of Military Justice. So help me God.

## First Amendment of the US Constitution:

Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.

#### Identified:

Man whom claimed himself to (me as): "Brian," driving school bus 210 for, GoldStar Transit, out of base: Cedar Creek, Texas. White male, 5 foot 11, approximately 240 pounds, uses glasses – has been caught using Project Artichoke and MKUltra, on a common US citizen.

His purpose was to cause harm, (possibly even) a bus accident. I warned this individual not to mess with me – after I realized – he was using MKUltra – by sitting away from him, and putting headphones on and listening to music, as a deterrent. To, "Force," his attempts to use MKUltra on me, further – he would grab me, and message me – then request I lower my headphones, to speak with me. He did this on 2 different occasions. On his third attempt – I refused to lower my headphones – as further demonstration, for him to leave me alone. Then, I got up and left – to do something else – and he still persisted. Where I simply went to the bathroom. This upset him a great deal. So, he had his wife – while I was waiting to sign-in (to drive my school bus), grab my neck, and further harass me. Then, the woman parked her bus in my spot (23), claiming what she did was a, "Mistake," but also refusing to move it.

## **Prior Issues:**

As I have done before (in this company): To draw attention to various issues, I sent emails to management. The most notable (prior) issue: Creating air leaks in my brake system, until the brakes did not function properly. Thus, I created enough havoc (emailing the Texas Rangers and various law enforcement agencies) until an upper-level manager (Paul) got in touch with me. Note: There have been no more issues with my school bus, since.

## Note:

I didn't want to get into the actual specifics of what was, "Really" going on: About my attempts to identify a possible "Mason Chattel" that could be turned into a, "School Shooter," or other purpose.

#### Child Identified:

The child (in question) has been identified, and local law enforcement has been notified.

Two other – younger – children have also been identified as possible "Issues."

## **Further Warnings:**

But, I wanted to warn this ex-service member whom calls himself, "Brian," (again). I requested the company I work for (the management of GoldStar – by email: Brittney Crop) to speak with this individual – and his wife – for them to stop grabbing me.

To further stress the importance of leaving me alone, I threatened violence against anyone that further grabbed me. At which time – the next day – a manager (Andy) went to the Cedar Creek Base, but oddly enough, the harassment persisted, and the manager didn't prevent it. As I waited to sign-in, "Brian," began grabbing my sweater, claiming he was taking, "Dog hair" from it.

## Note:

Both "Brian" and his wife – demonstrate extreme immorality – disrespect and arrogance. It appears they believe themselves to be superior to others – which would go completely against American values of "Equality."

#### **Further Notes:**

The physical contact and the harassment – is of little importance – compared to an ex-service member using MKUltra language – on an American citizen (whom understands *it*, and operates as MKUltra). There's no doubt in my mind, "Brain," was in-fact directed to harass me, using MKUltra, and notified I operate as MKUltra.

Within the "Deep State" – MKUltra (which affects and uses the organs and entire nervous system throughout the body) is specifically only supposed to be used on US Military service members. But "By Law" cannot be used – at all.

Within the "Deep State" – Project Artichoke (the numbing of the Vagus Nerve) is only supposed to be used on common, non-service American citizens. But "By Law" cannot be used on anyone.

Note (For Reference): See various Secret Service, other Federal, Local Police, Texas Ranger, and State Police investigations that I am under, and have been since 1999 (when I was 22 years old – here in the US) to assist you in answering any questions about – who I am – and my various actions and purposes.

Listen to the recordings, and the language, "Brian," used – to create the elevated, "Subconscious Fear," and the, "key words" and phrases – for his direction. I will not go into further specifics about what went on – and the results – of "Brian" using this language – which have been noted.

#### **Continuation:**

There was nothing I could say or do to prevent this individual from not physically harassing me, nor did the company prevent this man (their employee) from the harassment.

That afternoon – another manager (Lisa) called all on the radio to inform, "all," in the company – but I assume her message was (in fact) directed to me – for "Nobody to use the bathroom." We are not allowed to. And the base, will be, "Closed," to anyone that returns after 6 PM.

Note: Bus 210 arrived at the base – just before me (approximately 6:11pm): "Brian" if that is his name – refused to do his bus's post trip inspection – but ran into the Cedar Creek Base. I am not sure why.

When I arrived at the Cedar Creek Base – I completely my bus's post inspection – and went to the office to, "Sign-out." The base was actually open – which went against the prior notification by manager "Lisa," and the bathroom was – also functioning. It was then that employees directed me – that I was supposed to "Go

and use the bathroom..." But I did not need to use the bathroom, so I did not. It was at that time – that I noticed, "Brain" wasn't in the waiting area of the base, even though I saw him go in, and the back office portion (of the base) was closed. So, I assume – he must have been inside "The Bathroom."

Now, why Lisa, did or did not want me to use, "The Bathroom" and spoke at length about who was, "Not" supposed to and who was supposed to use "The Bathroom" – makes me wonder as to why I was told (when I arrived at Cedar Creek Base) I, "Should go into the bathroom..." by other employees.

The next day – in the morning (over the radio) I "Made Light" and joked about the extreme immorality and stupidity of those in the company, and Lisa's stupid message on the radio – thus was reprimanded.

## **Possible Plot:**

Note: The prior mention (minor conflict) is of no consequence, and has no bearing on "What is (and was) really going on." I can only assume – a great deal of bus drivers and management, know about what I will now explain:

Per prior Travis County Sheriff Reports – already filed – I have identified several, "Chattels" Mason "human possessions," that have the majority of their conscious mind, moved to their subconscious, for any number of reasons.

Individual in question: Creekside Intermediate student – identified in Sheriff's report (whom will remain nameless here) is a classic "Chattel" Mason Human Possession.

With all the "Tells" and "Markers."

- 1) Unaware
- 2) Draws
- 3) Poor physical awareness
- 4) Sleeps during the day (exhaustion from elevated subconscious fear)
- 5) Out of character rage
- 6) Low Conscious IQ
- 7) Appears and acts, as a younger child
- 8) Low interest in anything going on around him
- 9) Isolation little to no communication with others

#### Note:

Almost his entire conscious faculty has been transferred to his subconscious. And (possibly) a teacher has been elevating, and training his, "subconscious fear," to explode with anger. He often passes out on the bus, and will sleep the entire trip. Another reason I believe a, "Teacher" (a former member of a sorority) has been working with him: He has demonstrated extreme (out of character) anger (rage).

Next Step in Process of Creating Murderous Rage: A "sexual deviance" act will be trained into his "Subconscious Fear," for him to act-out (soon). If not already done. This will create the condemnation of the church and society – to expound his hatred and anger.

## Hypothesis:

I believe – "Brian," was tasked with forcing me out – to take-over my bus route (204) – to further develop (identified student). For him (the student) to "Act-out" and possibly become a "School Shooter," or "Church Shooter," or another purpose, as a (typical Mason-Military style) Special Forces Guerrilla Warfare "Mass Retaliation Tactic." These incidents happen – for various reasons. Most notably: Anything done or permitted by a city or town, that goes against the Secret Society (The Masons)...

## Question:

Why are ex-Military members that know, understand *and use* (thus break our laws) Project Artichoke and MKUltra on common American citizens, driving school buses?

Note: I know there's a grey area, for politicians, the judicial system and military service members – but these individuals are running these projects on common citizens – and I assume school children.

And he (the child I identified) was placed on my route – to further shame me, if and when he committed his violence.
