CLASS ACTION CIVIL RIGHTS COMPLAINT: *with* the objective of defending the United States of America; our citizens, against Mexican insurgents, & their associate gangs (all illegal immigrants): especially those that are allowed (by Mexico) to cross the border (to be indebted – and must payback, to Mexico *in* crimes) with the objective of creating poverty, lowering American values, creating chaos in our country & finally – reclaiming California, New Mexico, Nevada, Arizona & Texas – for Mexico

I hereby – request – the court recognize:

No one that is in this country – without Citizenship – that has entered our borders illegally, or overstayed their visa – has any rights, protections, immunities, by our US *of A* Constitution.

VI. Relief:

I – Kelly Michael Velayas – of sound mind, body and spirit – US citizen – do request:

- 1) The US *of A*: our Federal Government – recognize “The Mexican Mafia” as a Terrorist Organization: within the boundaries of this nation – Domestic Terrorists.
- 2) US *of A* Federal and Civil Courts are only for USA citizens – and will not permit a non-USA citizen to appear in our civil or criminal courts of law.
- 3) Military courts will decide cases for illegal immigrants: those who've over-stayed their visas and entered the USA, without USA Government approval, and or permission.
- 4) Nobody in the country without USA citizenship may obtain a USA Drivers Licenses – of any kind. If they are here on a Visa – they must obtain a DL from their country – or an International Drivers License. To be renewed – obtained – from their country of origin.
- 5) Nobody without a valid (non-expired) Visa, or American Citizens – can work – or open bank accounts, obtain loans, of any kind, or purchase a house – or open businesses.
- 6) Everyone that crossed the border illegally, without obtaining approval by the USA Government, to be recognized as insurgent for Mexico – and therefore declared "Domestic Terrorists" – under the Patriot Act.
- 7) All in the country illegally, without obtaining approval by the USA Government – for entry – that have committed a crime – cannot be placed in a jail with American Citizens. They are to be exited out of the country – to serve their time in jail – outside of the USA.
- 8) A freeze on all Mexican immigrants obtaining American Citizenship. Because of the nature of Mexico's decision to wage a covert war against the U.S.A.
- 9) All Visas – of Mexican Immigrants – to be cancelled, and those individuals deported back to their country.
- 10) Enact an "Enforcement Provision" under existing laws passed by Congress – The Patriot Act – so police officers can question anyone at work – to assess who speaks English – and where those individuals are from, for them to assess who is in this country illegally. For those individuals to be fired from work – taken into custody – and or deported.
- 11) Enact an "Enforcement Provision" under existing laws passed by Congress - The Patriot Act - for Law Enforcement - to issue a Ticket/Notice or Citation: For that person – or family – in the country (USA) illegally (without a valid Visa – or whom entered the country illegally) to be given 1 month to exit on their own accord – before a Warrant for their arrest is sworn-out.

- 12) Everyone that crossed the border illegally (without USA approval) and gets deported – if found within the USA – again – a Warrant for their arrested will be sworn-out automatically – as high priority criminals – and taken into custody – and sent overseas – to be released overseas – not taken back to their country of origin.
- 13) All children born to illegal immigrants – to be deported back to their country of origin (especially those from Mexico) – with their parents, considering Mexico has been waging a covert war against the USA, for decades – using Mexican insurgents (see affidavit for lawsuit for further explanation).

Additional Request for Relief:

I, hereby request for additional relief a Legal Provision – for Law Enforcement: A Ticket, or Citation (of a fine, of \$500, per incident) for employing, contracting – paying for labor – any illegal immigrant: someone who has either overstayed their Visa, or entered the country illegally.

Additional Request for Official Recognition:

I would like the Federal Government to officially recognize that an Act of Congress (the Patriot Act) cannot overwrite the Constitution (take away American citizens right to Free Speech). That includes insults, threats, screaming, crying, outrageous claims, lies, slander, blasphemy, rhetoric, et cetera – every form and type of the spoken word...

And all those in jail, for simply exercising – Free Speech – to be set free.
