**II. Body of Affidavit:**

**Fact: Mexico declared War on the USA – a long time ago (over 30 years ago). It took them a while to find a means (a system that works) for their illicit war – “Criminality.” We must recognize *it*, and retaliate.**

A-Typical Mexican Politician/Government employee that represents a foreign government:



Eduardo Martinez – a government contract/employee/regulator – working for Manatt, Phelps & Phillips, in California, has stated to me, that he hates America and Americans – believes Mexico should take-over California, and the entire southwest – and if people say something he doesn't like (use Free Speech) then he “Feels” that he is “Oppressed” or being, “Abused.”

\*These are just tactics/ploys – to shutdown critical analysis of their corruption – stifle Free Speech – end debates. And it's a disgrace that our colleges – institutions of higher learning – are teaching this tactic – rather than teaching American values of – open and honest – debate. He went to University of California at Berkeley.

This is someone that is given political oversight/power – in our country. This individual – and his values – are a disgrace to America. He is a traitor – practicing treason. He even tells people that he is – and he's still given political power. This practice, is beyond stupidity.

He doesn't believe in the US Constitution. Doesn't believe in the First or Second Amendment – the same Rights that he uses to tell Americans they are evil – and we need to be conquered by a country that still practices slavery (Mexico) – as all Latin American countries do. He doesn't speak Spanish, has never lived in Latin America – or Mexico for that matter.

When I asked him if he'd like to spend some time in Latin America, so he could better understand what the values he represents: I said I could show him, “Where I've seen slavery...” (in Brazil, Venezuela – and farms in Mexico). He said “No,” he doesn't want to understand anything.

His idea of a career, is selling-out his country (the United States of America), and allowing Mexico (a foreign country) to controls the streets of California (and a great deal of the Southwest), and thus, all low-level, unregulated jobs are given to illegals – so Mexico, and the Mexican Mafia can have more power in the USA.

**Fact:** He gets his ideas and values from his mother: She tells everyone that she hates this country. She lives in the US illegally – she has lived in California for decades – she doesn't have a job – lives off her children, and refuses to follow our laws – or file for citizenship – but she refuses to return to Mexico – and doesn't want to live there...The conflicts (paradox) that she lives and believes (in her mind) is complete insanity.

**Question:** Why are individuals that believe the US should be conquered by a foreign country, and assist in that endeavor, given any political, or oversight – or regulatory power, in this country?

I – here by – swear I have been in a Mexican jail – and Venezuelan – and I've seen Mexican jail guards rape and torture an inmate (a Latino). They played Russian Roulette – ripped his clothes off – beat him – gut punched him – spit on him – repeatedly knocked him to the floor – shoved objects up his anus.

\*This was Mexican Government employees that did this. This is common practice – and represents the lawlessness, by Latino cultures – that we allow and empower in this country.

The torture lasted all night. After a 30-minute session – they left the individual on the floor of the jail – crying for an hour – to return and begin again. They made me watch the torture – as a means to scare and influence me.

This is one of the many steps that the Mexican government uses to create and train, criminals/Mexican Mafia insurgents, that are forced to illegally cross our southern border – to infiltrate and create chaos, in this country. The insurgents are trained and processed in the Mexican jails. The Mexican Government turn these men into animals – make them into government soldiers (spies – assassins – secret agents) without recognition of service.

The crimes they commit in this country – not limited to: smuggling drugs across the border, and into jails. Our Latino police officers and jail guards are forced to participate in these crimes. They control all Latinos – and the Latino Communities in this country – corrupt elections – corrupt government – corrupt police – corrupt jails – all of our institutions – using tools, like Eduardo Martinez, to do their bidding.

Note: I have seen Mexican jail guards (Mexican government employees) negotiate with a Latino – to assist him to cross the border illegally – for him to owe the Mexican (government representatives in the USA) – the Mexican Mafia – \$10,000 (on credit) that would accrue interest – and he would have to pay back, with cash – or crimes against the USA.

This is another tool that the Mexican Government uses to create insurgents in this country – using Latinos from other countries. Fact: Every individual that crosses the southern border illegally (Independent of the country they come from) owes the Mexican Government a debt – that must be paid back in crimes (against the USA).

I have also seen a woman that crossed the border illegally – that was forced into sexual slavery for the Mexican Mafia – to pay for her illegal cross. This is common practice.

Note: And the many death grounds, on the Mexican side of the border – are Latinos that the Mexican government believes – would not be able to pay back the debt (of \$10,000) if they were allowed to cross illegally. When they do this – it is a warning – it serves as a tactic – to threaten those that cross, what will happen to them, or their loved ones, if their debts are not paid, after they cross.

Doctors of foreign countries are forced to do illegal – home surgeries – same as dentists. I’ve seen this with my own eyes. There are 2 apartments in Marietta, Georgia Ashborough Village Apartments. And there are other locations in the Atlanta, Georgia area – I have seen. I even had illicit dental work done by a dentist, at his home.

Secret corridors are built – in attics, basements – underground shelters dug in sheds.

Note: If a high-ranking Mexican Mafia insurgent is sleeping at a house – the Mexican Mafia will control the entire block – and will hid the individual in a different bunker (or house) other than the one he entered. I’ve seen this with my own eyes. All of your gang housing – are done in the suburbs of cities (mostly large cities).

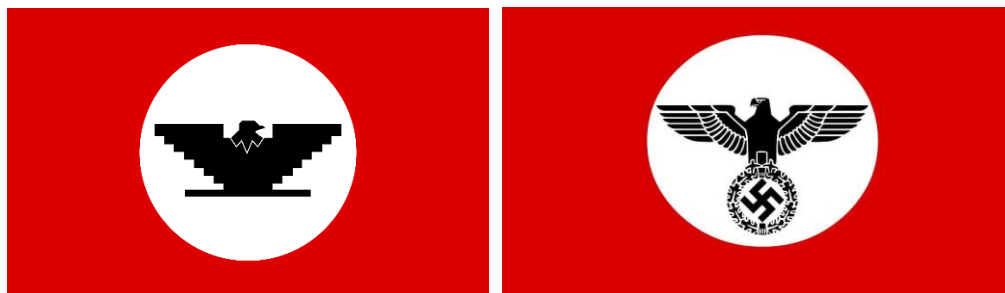

Everywhere the Mexican Mafia takes over – they take all the low-level jobs from American citizens (poor whites, poor African Americans, poor Latino Americans). They take over the streets – prevent people from working – give jobs without much oversight to illegal immigrants. These individuals do not pay their taxes. Example of a failed state: Look at New Mexico, where Mexico controls. Commerce and competition is stifled by a foreign country (Mexico). New Mexico actually, more resembles Mexico – a Third World Country – more so than the USA.

Our law enforcement do not want to pullover vehicles they know are full of illegal immigrants – for fear of putting so many illegals (foreign insurgents) in our jails – with American citizens. The results – are more and more corruption, and lawlessness.

I have worked as a clerk at a gas station – during approximately 1 month – at least 80 illegals (without USA drivers licenses – that couldn't speak English) either attempted or did purchased alcohol. Often, they were in large groups. They did not have USA Identification. Yet, they drove vehicles, and had jobs in this country.

Many Americans want to work the jobs the illegals have (and control). The illegals have lowered rates so low, Americans can't financially survive doing these types of jobs – or they very simply – are not allowed to work these jobs by the Mexican Mafia (those that control our streets). This is just another aspect of Mexico's control (a foreign country's dominion) over the United States of America – and our citizens.

Everywhere the Mexican Mafia takes over – they take control of our jails – courts – thus our politicians. They do this with corruption – smuggling drugs – threats – murders – leverage to prevent their enemies from working or providing for themselves.

And yes – it is true – all of our homeless are American citizens – *that can't get work*, and there are few to no Mexican homeless (in this country). But, in Mexico – and throughout Latin America – the homeless crisis is off the charts (and there are no homeless Americans in these countries). Homeless children roam the street. Minimum wages (per month) are on average \$200. The poor are kept poor. Income tax is 50% to 60% of wages earned. There are no laws – the poverty is so great – nobody can buy land to build a home. They “Encroach” – “Squat” on land – claim land, and build on land without ownership. This is forced by their own lawless government.

Politicians and Judges – pass down their pensions to their children – their allies are given fake jobs – and allowed to retire, with full salary-pensions after a decade or (at most) 2 decades of fake labor/work. The healthcare system only functions for the powerful and affluent. Doctors harvest organs from the street children – to artificially extend the lives of the elites (politicians and powerful). Police officers rape fellow police officers in police stations (example: Sylvia Regina Gomes de Lima – of the Civil Police of São Paulo). Children are intentionally killed by police officers to create chaos and riots – sometimes, this is done, just so the rioters will kill and unwanted police officer.

The corruption is off the charts – common. For example: In the municipality of Alfonso Cunha, in the state of Maranhão, Brazil – in the rural areas – I've seen slavery in its classic form. Owners whip their slaves, and mutilate and kill their children. \*I've also seen slavery in Venezuela, and heard about the slavery in Mexico – and heard individuals claim to have been slaves (in Mexico).

Note: These Latinos take pride in their corruption – and believe it to be a strength.

Other examples of corruption: The National Guards (in Latin American countries) are used against law-biding citizens – killing those that seek political power – they slaughter families – sometime entire communities. Revolutionaries and militia groups, are also used in this capacity. Drilling a water well can get you killed in some communities, in Latin America. Changing work procedures – technology – and other forms of social advancements – that those in power believe to disrupt the Power Structure – will not only get you destroyed – but your entire family – or town.

Mexicans, that live near the border (southern US border) want the border completely closed – shut down. Mexican Mafia gang members (that control the towns) will walk-up to mothers and fathers – and tell them that
