I. BODY OF AFFIDAVIT

Cocaine is not a drug – just for recreational use – as it is portrayed in movies and TV shows.

In Latin American – Coca – and Cocaine is a “Culture.” *It* is a way of life. And for the Latino Drug gangs/cartels it is their main tool – that reaches all the way up into the highest places of power, in American society. The drug is weaponized, by various means and methods – thus transformed dependent on the “The Mark” – the victim.

There is a method to use this drug on women and girls – to weaponize it into an unstoppable aphrodisiac, dependent on where and how it is placed on the body. Most often it’s used on underaged girls, to turn them into prostitutes.

There is a catalyst that can be used – to make this drug so addictive – it’s nearly impossible to stop using.

There is a catalyst that can be used that will erode the mark’s nasal tissue. Often this is done – then the victim is sucker punched in the nose – concaving the entire face – or they simply bleed to death or asphyxiate after the nasal cavity is empty and blood from their brain drains into esophagus.

There are different catalysts that can be used – dependent on how the drug enters the body – that will attack specific organs – rendering them inoperable – and the mark will need organ transplants.

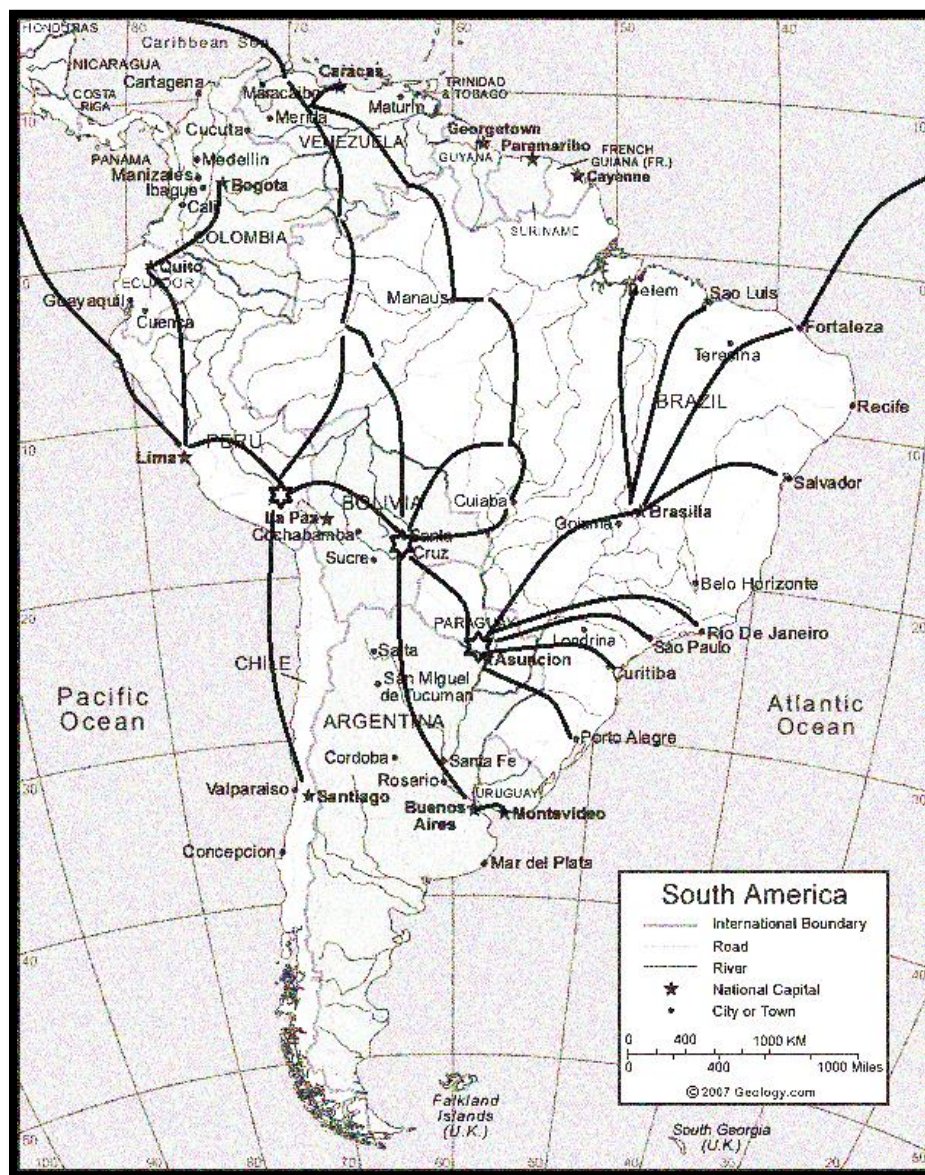
The amounts of cocaine available in Latin America – is staggering – in comparison to what is available in the US. It (cocaine) is a culture. There is so much – there are so many ways to use it. Americans – with their limited – and the excessive price disparity cannot even imagine – nor if they did – would never have the money to experiment – to learn it’s various qualities – and illicit uses.

Crime begets crime – and the more we allow criminal gangs to enter this country illegally – the more harm they do – the more crimes are committed. All Latinos in this country – illegally – and a great deal of those here legally, are owned by Mexico – and must commit crimes against America and Americans – to prevent the criminal groups from going after them, and their children.

The endless amount of homeless in all Latin American countries – exist for a reason, and purpose – a pool of bodies to be abducted – for various reason – not limited to the ultra-rich – to extract organs. All Latin Americans know this – and there has even been movies about this tragedy. The 1998 movie *Central Station* – that was nominated for an Oscar – was about this aspect of Latino culture.

The 3 major producers of cocaine: All of Bolivia – several regions of Paraguay – and southern Peru.

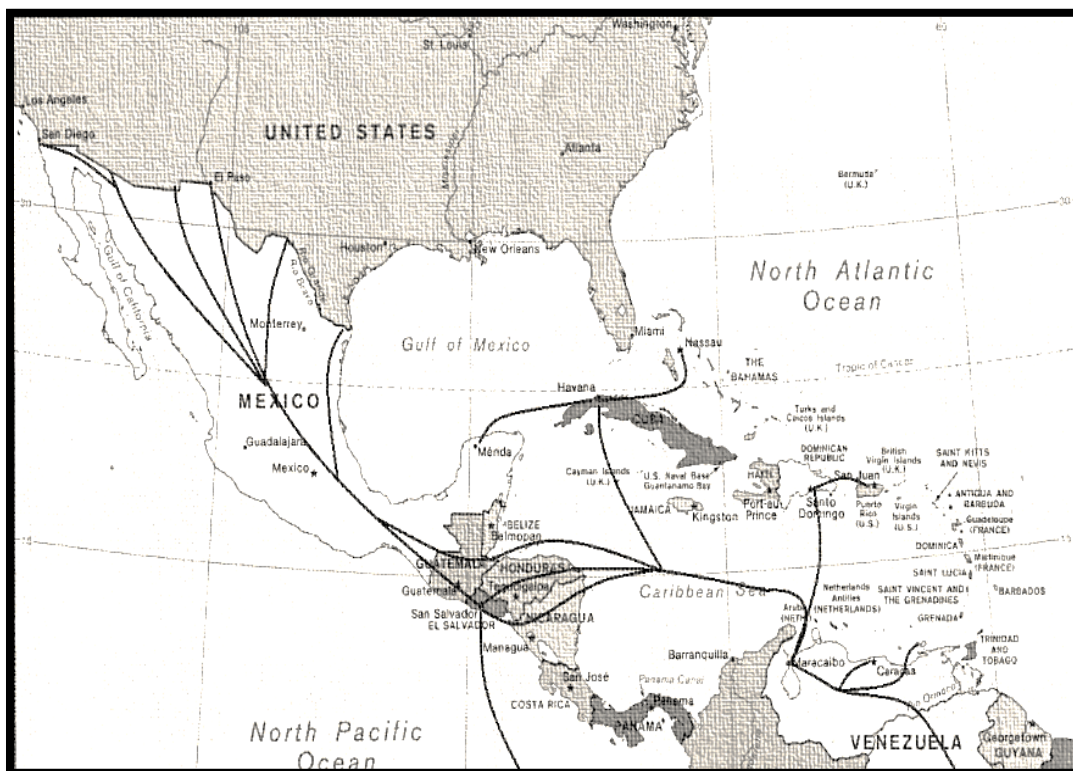


The majority of cocaine (about 80%) that travels into the United States – goes through the Central-East Venezuelan mega-cocaine-hub (or block) of Barquisimeto-Valencia. From there – it goes to Maracaibo, Venezuela, then, “Around the horn,” by boat – avoiding the country of Colombia.

Cocaine routes into the US – are mostly vehicle crossings in California, Arizona, New Mexico, El Paso and Brownsville, Texas – with tunnels crossings where houses are near the border.

All of cocaine travels to its destination – uncut. When cocaine “cut,” will be done – dependent on the buyers – in the area (the market, or individual that purchases it). Chemicals will be added – if there is a “mark” to cause organ and tissue damage. This is much more common than you might think.

Argentina controls all – International – drug trade throughout South America – into Central America.

Mara Salvatrucha (MS-13) is the lower-level enforcers of the Mexican Mafia – and carries/controls – with the permission of their overseers – Mexico – all Central American drug traffic – even through Mexico.

Argentina – controls all drug routes through Brazil – even in the Amazon. With the town of Novo Progresso, in the state of Amazonas – as a main cocaine corridor through the Amazon.

Note: As a form of protest against local politicians – Brazilian farmers will use bulldozers to destroy the main bridges that transports cocaine to Venezuela – to prevent payoffs to local politicians (from the drug cartels) or divert drugs to different routes in the Amazon.

Note: Gang members of MS-13 (El Salvador) – when they've obtained a high enough status (committed a great deal of crimes in Latin American) are allowed – as a reward – to enter the USA – to wreak havoc.

Argentina controls all aspects of the countries of Uruguay – Paraguay – Bolivia – and to a great extent – Brazil – especially southern Brazil, through the Masons. Southern Brazil is the main producers of food in the nation. Argentina is even allowed to abduct young Brazilian girls in Ciudad Del Este, Paraguay – and I've seen the results of the abductions. The same individuals that smuggle the drugs, assist in the abductions. The girls are chloroformed, then transported by baggage to Buenos Aires, Argentina – I assume to port – to be transported to different location in the world.

Argentina sabotages all advancements in transportation – in the countries they control, by threatening local, state and federal politicians – through various means – mostly using their cocaine distribution network. The criminal groups that assist them, will in turn physically harm politicians and their families. A common practice

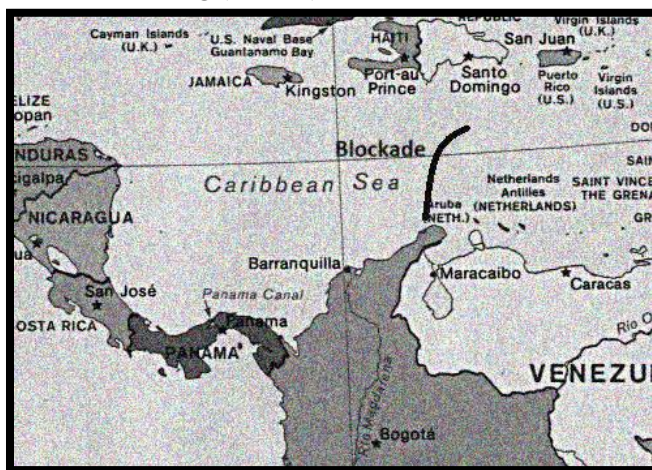
is, two men on a motorcycle – drive by a victim walking on the street. The man on the rear of the motorbike, will have a 2x4, with several nails protruding from the end of the 2x4, and will slap the victim in the lower spine – with the nails of the 2x4 – paralyzing their victim. When this happens, no law enforcement will help the victim, because they know why the attack happened. Only the cartels attack victims in such a way.

The courts will not condemn – or rule against any of the cartel's frontmen – even when they are foreigners – and stealing from locals. I have sued a high-ranking Argentine gang member – in Brazilian courts – who even stole from Brazilians. I won the suit – but wasn't awarded compensation.

Argentina also uses the poor transportation network – and their political power – as a means of control – over all southern, South America counties – like a vice. Argentina – is – in fact the worst offending criminal nation in all of Latin America.

Action: To further disrupt (to create additional chaos) with the Mexican government's – criminal networks – within the US – the Mexican Mafia – I recommend a blockade – in International waters, near Colombia's Northshore – extending out +150 miles.

First Blockade: To shut down all – major –
drug (cocaine) routes to Mexico



After this blockade, I expect the drug routes to shift to the secondary – Western Route – from Peru – to El Salvador.

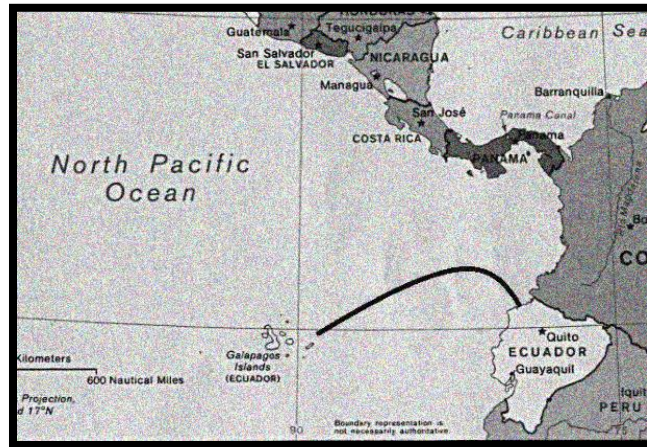
Note: I would maintain patrols of the Darien Gap – if land crossings begin, first from Venezuela – then Peru.

Note: Venezuela will be completely destabilized by the above blockade – and Nicolas Madura might eventually be assassinated, if Venezuela loses the drug (cocaine) traffic – through their country.

Note: Expect a third option from Venezuela – transporting cocaine to Margarita Island – then Barbados – then up the Antilles to Nassau, Virgin Islands – then into the various Eastern ports.

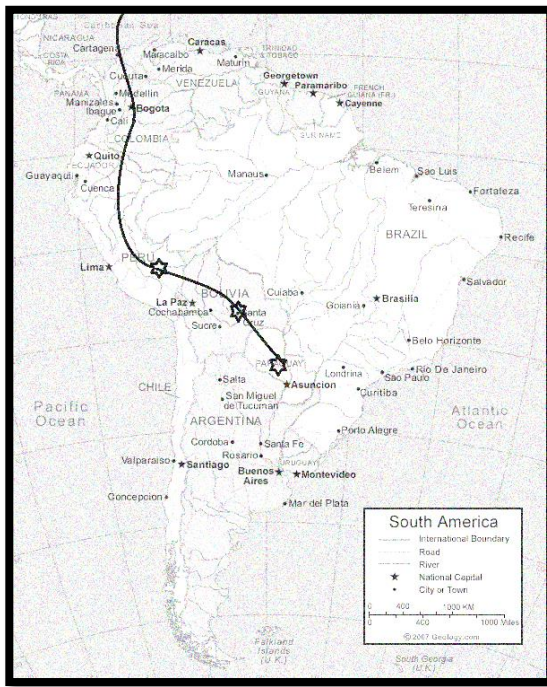
Secondary Blockade: To shut down all – major –
drug (cocaine) routes to Mexico



After this blockade – I advise sending a delegate to Paraguay, Bolivia and Peru – to reroute all cocaine to Colombia – then through the Caribbean – to Cuba – and from Cuba – to Nassau, the Virgin Islands – and from there – in moderation – to be smuggled into the US.

Note: All crime is a negotiation. Cocaine will get into the US – somehow – somehow. The important aspect is that it's not being transported by our enemies – and used against us as a form of weapon.

See routes below. This (pathway) can be maintained by stationing – and maintaining a presence in strategic locations. The major highways through the Amazon. Identify – anyone from the narco-producing countries, and Argentina – for contraband – in the various buses.

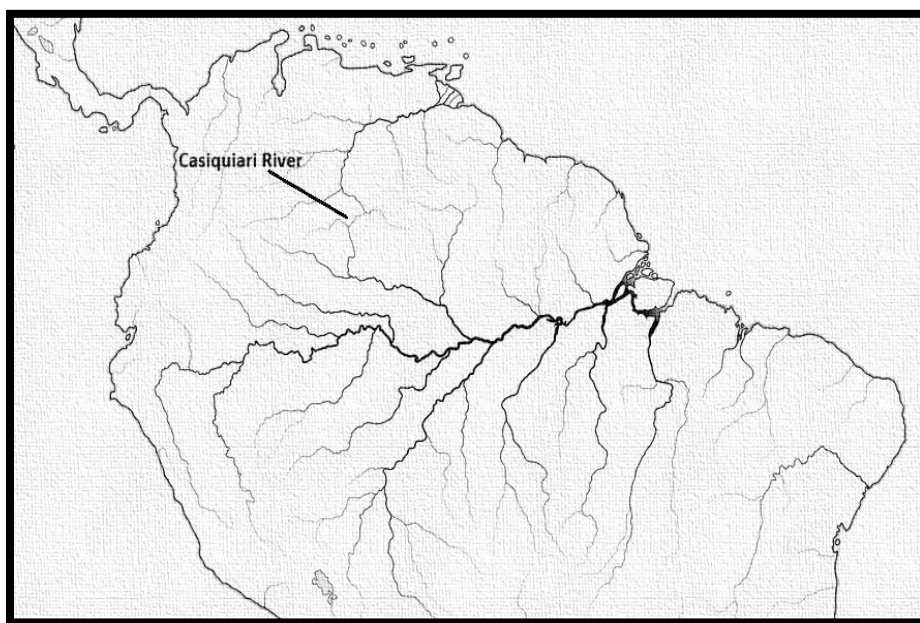
This route – will destabilize our major enemies (those that cause the US the most harm – Argentina, Mexico, Venezuela) and stabilize out allies (Chile, Brazil), by incentivizing transportation investments – by shutting off the payoff system to politicians that prevent such investments.

Throughout the southern Caribbean – we can keep a presence on the various routes – with the exception of that to Cuba, and from Cuba – to the Virgin Islands.

The route – in question – should be through the port of Cartagena, and not Barranquilla, because of the close association of the Barranquilla gangs, with the Venezuelans.

Note: Keep – the border secure from Colombia and Venezuela. Do not overlook the crossing of Puerto Ayacucho. A major crime hub – in the Amazon region.

Also, watch the Casiquiari. Which at some point – I believe – as a last-ditch effort – will be used as a method of transporting cocaine from Bolivia-Brazil-into Venezuela – through the river systems. This is a body of water (a natural canal – 155 miles long) that connects the Amazon River system with the Orinoco River system.



As you can see, one can literally go from Bolivia, through the entire Brazilian Amazon – by way of the Casiquiari – into the Venezuelan Amazon, then down the Orinoco, into the eastern Caribbean. This would be an ideal method of transport, with the exception of the various dams and other major river debris and rapids, that cause damage to vessels.

Note: The Amazon River tributaries are still very dangerous to navigate and some areas are still controlled by hostile native American tribes that – to this very day – will attack foreigners – especially criminals and drug traffickers. As they are still in a struggle for survival.

Additional notes: The majority of cocaine – when transported on land – in Latin America – is done by bus – in small carry-on bags, that are kept in the above storage areas. Most shipments are small – 3 to 4 kilos (per

bag). This is done to avoid the drug detection dogs at various checkpoints – on the highways. Dogs are not brought into the bus's airtight luxury cabin – thus the drugs remain undetected.

Note: the production of Coca – from the Coca Plant – is legal in Bolivia, and is still used in open society (unrefined). This is very common around the silver and gold producing mines in the Andes. The plant – helps keep arteries clean and lessens the effects of various contaminants.

Coca is refined into cocaine – in cities – where the drug cartels takeover entire city blocks – while from the streets – the houses look normal. Where in fact – within these are drug/brothels. There will also be illicit medical procedures and various other crimes done within these compounds.

Note: The Mexican Mafia is doing the same thing – within the United States of America – especially in areas they take control: New Mexico, California, South Texas, Arizona, Nevada...They takeover entire city blocks. Its more hidden here – than it is there – but with the same Modis of Operandi.
