II. Body of Affidavit:

Hidden bunkers/hide-outs – created by the Mexican Mafia (Mexican Government) throughout the USA – to hide their Mexican Insurgents – for extended periods of time...

Note: It's been almost 20 years, so bear with me...

If I remember correctly -- in 1 of the 3 building (see image below) -- in the attic -- is an area -- at the North end of the build, where there is a room sealed-off/built (in the attic). It is very well done, and looks like it's supposed to be there (if you're in the attic). The access-point to the hie-out, is in a closet, in the apartment below.

They put these hide-outs at the end of the buildings -- because that's where the air-vent is -- and it will appear normal. If you aren't look for (it) -- and your spatial awareness isn't working (at the time) -- you'll overlook (it).

Note: Sitting in rooms -- with a great deal of people -- in the jails in Mexico -- is another aspect of the Mexican Mafia's training techniques. *They can go years -- just sitting in rooms -- with a bunch of guys.

I was actually allowed to go into that room -- through it's access point (in the apartment below.

Note: The location was there in 2009. Maybe it's still there. But, I doubt there's anyone in the hide-out -- but then again -- you might get lucky.

*If you do locate it. I would go through the rest of the apartment complex's attics (throughout the entire Ashborough Village)...and see if you can find others.

Various criminals -- have used that location to hide-out -- for months at a time.

When I was there -- they didn't install a bathroom. The men would pee and poop in bottles.

These types of locations are all over Atlanta, Dallas, San Antonio, Boston, El Paso, Houston, Denver, Chicago -- throughout California.

Note: The American maintenance worker that was there at the time -- knew about the location, but was afraid to talk about it...

This is why -- The Mexican Government (their Mafia) -- wants to get their Illegal Immigrants in place, as maintenance workers. To hide/protect their criminals.

Note: All the immigrants in the community know about these activities. Many try -- not -- to figure-out too much. Some enjoy it. All must go along, and hide it.

If -- The Mexican Mafia -- has already taken-over the Maintenance position (in this apartment complex) don't expect any help from him (or her).

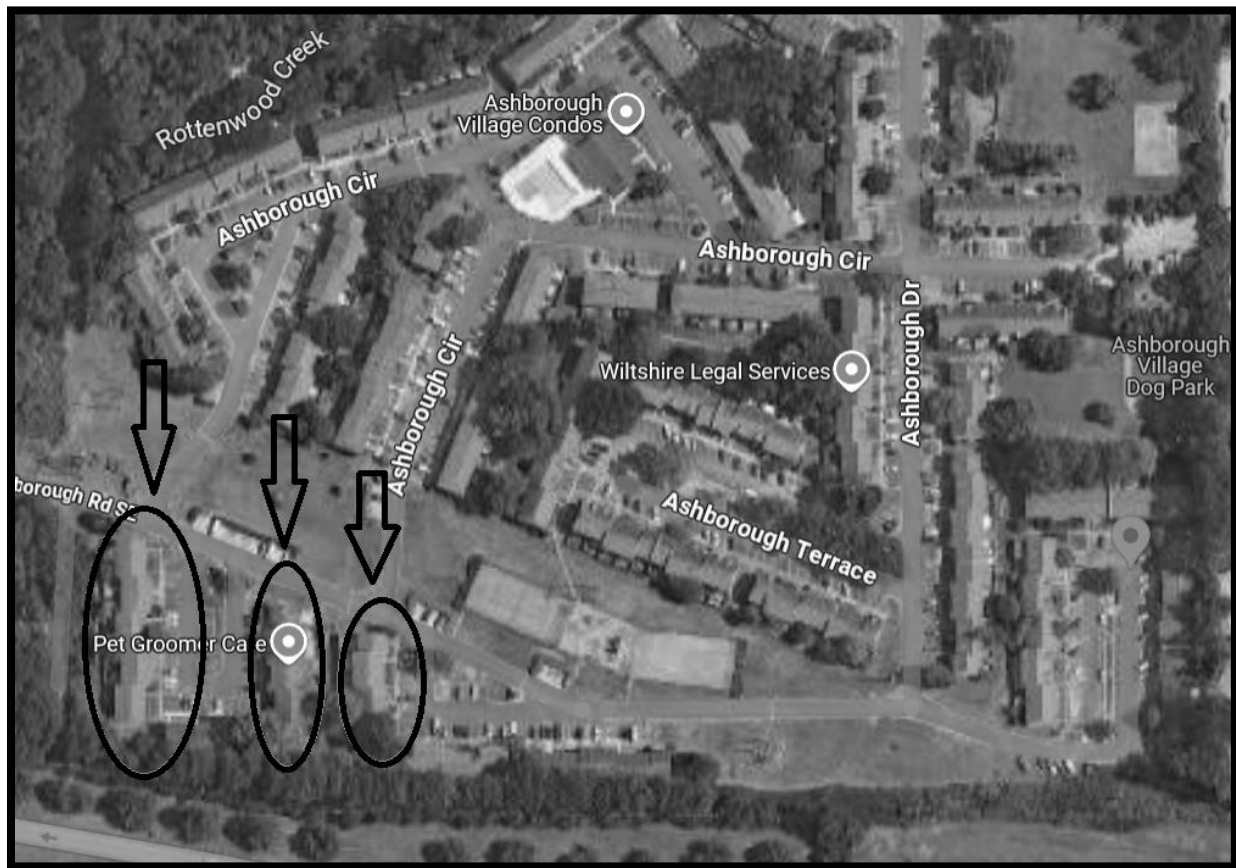
Note: Roger Pezini -- who was an Illegal Immigrant in 2008, and probably still is -- communicated and assisted the Mexican Insurgents -- hiding-out in that loft. He was (and probably still is) heavily connected with the illicit Mexican Mafia Insurgents in the Atlanta area.

Often, a vehicle would park on the drive, in front of the attic hide-out – and communicate with the Mexican Mafia Insurgents.

Note: These locations are built very quickly, often in 1 afternoon – while a car is “broken-down” in front of the apartment building – and the owner of the car – will act like he’s working on his car – trying to start his car – making noises – as those in the attic build.

Ashborough Apartments, in Marietta, Georgia



Most often, the “Attic hide-out” is placed near the entrance of the apartment complex – like this location was. The reason Mexico does this – is so their Insurgents can monitor who enters the complex, and they will be near the exit, if they must leave (for whatever reason).

Note: Usually, where there is 1 attic or basement hide-outs – there will be others.

It will be hard to access (or find) the access points, from the apartment (below). The easiest way to identify the entrance is to find the attic room, break a wall, and enter.

Note: You will want police officers at the entrance of the apartments, while the attic room, is being accessed, to catch anyone that attempts to escape while the entry (to the hide-out) is being made.

Note: There are mobile home hide-outs, also, built underground, under the floors of the mobile homes.

Quite often, the Mexican Insurgents (those who have obtained a great deal of power) will never drive anywhere.

They walk or have someone else drive them. Roger Pezini did this for the Mexican Insurgents, there in Marietta – he would take them anywhere they needed to go – all the while knowing the individuals were criminals (anti-American).

Mexico will take-over entire mobile home parks – and their Insurgents will leave their underground bunkers, at various times of the day – or night – to harass American citizens, or anyone that does follow their directions.

In Boston, Mass – while living in Summerville, Carlos Valente (of Faxinal, Parana, Brazil) and his son, would also assist the Mexican Insurgents – work with them – and help them when directed to.

Fact: Those who assist the Mexican Insurgents (in their immigrant communities) will prosper. Those whom do not – will suffer. This is the “Influence/Control” the Mexico (a foreign country) has obtained – to harm our own citizens. For example: Because Roger Pezini helped the Mexican Insurgents – against the nation he illegally immigrated to, and “Where he wants to live, and become a citizen,” he obtains power in the community.

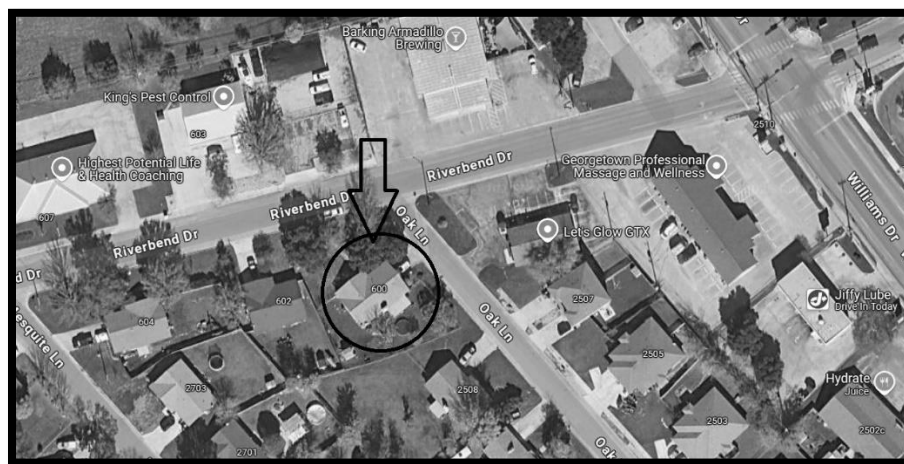

600 Riverbend Dr, Georgetown, Texas – where Mexican Insurgents have broken into neighbor’s homes.
