II. Body of Affidavit:

Income Tax & Welfare Fraud, by Illegal Immigrants:

In Marietta, Georgia – in a large Brazilian community – I heard many illegal immigrants, speak about using and defrauding the US welfare system.

Example: Rogerio Pezini, from Apucarana, Brazil. Who lives and works in Marietta (lived in Ashborough Village, circa 2007 to 2008). He worked as a laborer (when I knew him). He did yard work – tree trimming – house repairs.

His wife (Karina Pezini) spoke with many Brazilians – and encouraged them to file for welfare, regardless of necessity. And she would show them how to do it.

Rogerio admitted to hiding income from his labor. He did not declare (the majority of his income) – and his wife Karina Pezini, worked cleaning houses – and did not report anything.

House cleaners make – on average – \$80 to \$150 – per house cleaned.

A “House Cleaning Schedule” – which is maintained and sold within the Latin American community – can have as many as 20 to 30 houses – and I’ve seen a schedule of 50 houses.

Note: For the most part – house cleanings – are bi-weekly, but always – often they will be every week.

If the owner of the schedule works with a helper (who usually gets paid, close to minimum wage) the team can clean between 4 to 6 houses a day.

I’ve heard of immigrants making as much as 80 to 90 thousand a year (in 2007) – cleaning houses – while **not** reporting a single dollar – and still – receiving welfare checks, and food stamps.

This is common.

Where the Mexican Mafia controls, cash jobs are controlled by illegal immigrants.

This is the main reason America has so many homeless people. It’s not complicated.

This is also the reason, so many crimes are committed. The criminals that get out of jail, and have a criminal record, are blocked from performing these jobs. They cannot survive, specifically, because of the lawlessness, and our Federal Government’s refusal to protect American citizens, and enforce our laws.

The individual (the criminal) will have no means to support himself financially, so, he must steal for food. Criminality perpetuates – grows larger – while the illegal immigrants thrive.

The more illegals – the more desperate or own citizens become.

Note: Illegal immigrants have more opportunities, and more freedoms – within the United States of America, than American citizens, in their own country.

They have more support from their community – the larger their community grows – the more illegals enter the USA. They work jobs without oversight. They are not expected to perform civil duties.

Note: This – refusal to pay income tax – while receiving welfare and Medicare and Medicaid support, might appear to some as a, “small” fraud, but considering the illegal immigrant community has swelled to 15, or possibly 20 million...This can (and has) capsize an entire state (see: New Mexico).

Admitted Mexican Mafia Gang Member (in Austin):

Ricardo Reyna, that works at Charter/Spectrum – admitted to me that he was a high-ranking Mexican Mafia gang member. He splices fiber optics for Charter/Spectrum.

Ricardo – like many other – high-ranking gang members – are so stupid – that they tattoo themselves, so they can be identified. Ricardo showed me his wedding ringer finger tattoo. He identified that tattoo as a mark, an indicator that he is married to a gang (The Mexican Mafia).

Note: Patrick Wanker also identified his wedding ring finger tattoo, as being married to a gang. And, there are many others that I've seen identified in this way.
