Additional list of witnesses to subpoena – for testimony – to prove the control over society – by the White Gang – the neo-Nazis, KKK, Aryan Brotherhood, Masons and Eastern Stars, and their followers...Also: My email that was sent to the Atlanta PD – 14 days before the latest school shooting.

Chris Lee – who is ex-Military – and I contracted for as an Independent Contractor – and whose supervisor in Indianapolis, Indiana – gave-out my phone number to people I didn't know – with the specific intention – for them to text me to harass me as I work. And who illegally spoke about mental health – in a professional setting – only to upset me...And when I got upset – and began to argue – Chris Lee told me I had to speak with him – on the phone – without transparency – only so he could threaten me. I told him, I wanted to speak to him through emails and texts – so there would be a record of our conversations – and his response was – that he didn't want a record of what he was going to say to me – and that was the reason I wanted a record of what would be communicated. It was at that time – he said – he would not communicate with me through text or email – and then fired me. He then kept all the money he owed me for the work I did for his company – approximately \$8,000 – and refused to pay me.

He said I should be embarrassed about telling people the truth – which demonstrates that he's embraced female qualities.
