#### Latin American - Special, Elite Police "Death Squads"

An important aspect: Something all Latin Americans know and speak openly about: Everyone knows these units are specifically designed to kill. They are "Death Squads." Period. They are called, elite – or special police, but their only purpose is to kill, and that is all.

Almost every Latin American country has their own Death Squad Police Units. The following are the most recognized:

Venezuelan – FAES Mexican – GOPES El Salvadorian – SP of PNC Chilen – GOPE Brazilian – BOPE

So, what are they? Why do they exist? What do they do?

I lived and saw the Brazilian BOPE – with my own eyes – and watched them operate – so I will explain them.

1) The BOPE in Brazil travel around in cities – in buses – with as many as 50 military personnel – with machine guns – and will kill 100s of homeless children, over a weekend. When this happens – nobody reports the deaths in the news. And that is normal. It will happen – in Rio de Janeiro alone – 12 to 22 times a year.

Note: Riots – that result in 20 to 50 deaths in the city of Sao Paulo – happens 3 to 4 times a year.

2) Revolutionary Armies (controlled by politicians) are a standard in all of Latin American countries. I have personally seen one of these groups take over the city of Belem, Para. Often, they pass through and take what they want – sometime people.

Now, it's less common, but it does happen. They will take over an entire town – of 1,000 to 50,000 – and hold everyone hostage. Rape and murder of civilians are common. Most of the individuals in the Revolutionary Armies were former slaves – whom have been severally abused, and turned into killers, thus forced to become mercenaries.

BOPE will surround the town, and systematically kill the Revolutionary Army. These situations are always done for political purposes – and gains. Depending upon the population – 500 to as many as 50,000 will die. One of the instances that was brought to my attention – 50,000 were killed over a weekend. Again, nothing was reported in the news.

Note: Hostage situations are very common. Few get reported. Several situations like the above city have been explained to me. One, including a city in Sao Paulo happened in the 2000s. In Caracas, a hostage situation that included a high-rise building – and another in Brazil, that included an entire bus – were brought to my attention. In each situations – many were killed. I have personally seen riots where between 20 to 30 people were killed, many with Molotov Cocktails – in São Paulo, Brazil and Rio de Janeiro.

#### Slavery in Latin America

There are between 5 to 10 million slaves in Brazil. And those that are not slaves – most live as indentured servants. Slavery in Latin America is everywhere. Those who are slaves – likewise, their children will be forced into slavery, and share their fate. Those that are born into slavery, that don't wish to be slaves, will be beaten, forced to live on the streets – given diseases – forced to be mercenaries – killers – prostitutes – to starve to death.

In Maranhão, Brazil – in the Northeastern part of the country – slavery is common. I visited a slave farm (community). Men had whip marks on their backs. Their children were mutilated. The slave owner was the schoolteacher, the owner of the store where the slaves were allowed to obtain goods, the head of the community, the police, and the pastor in the church. He was revered as a God.

Children, as young as 3 years old were forced to break Babaçu nuts, with a hammer and knife – often slicing their hands and fingers, that in turn were infected. By the time the children were teenagers – each child was missing at least 1 or 2 fingers, on each hand. Often, they were missing limbs. Mothers complained of the children that bled to death. If the slaves attempted to leave the farm – they were run over on the road, by the various landowners.

I also saw slavery in the Brazilian Amazon – and Venezuela. I would even work beside these men – as the slave labor was forced to load and unload freight in the various ships on the Amazon River.

And in almost all towns – are slaves – forced to work in home (illicit) factories. Almost all manufacturing is clandestine in Latin America – because it's impossible to make a profit (legally). The work is done in homes – unregistered and hidden from sight. Thus, imagine all the crimes that are committed against the workers. All the women that work in these illicit factories, are forced to have sex with the managers. They are all, "unregistered" don't obtain minimum wage, nor allowed government work-related subside programs, for unemployment – time off – et cetera.

Many children are killed with impunity – I have personally seen this, in Venezuela and Brazil – young children. No investigations – no police – no reports. Their bodies placed in bags and carried away, while parents scream and cry.

Gang members rape children and women, with impunity – throughout all of Latin America. The Upper-echelon of Latino society – will literally drive around the towns where they live – to find underage girls walking home from school, abduct and rape them. This is common. Latino culture is a, "Rape Culture." Believe it or not – Mexicans that live on the Mexican side of our southern border – want the border completely closed. Because the gangs abduct their children and rape them – then turn them into sex slaves – without consequences.

Many girls are raped, then forced into sexual slavery – forced prostitution, because prostitution is legal in every country in Latin America. An aspect of Latin American culture is forcing women and even men into prostitution. This is a specific trait among Latinos – from Latin America – that have not become, "American."

I have personally seen girls, as young as 18 working in brothels in Latin America, that are forced to sleep with 40 men, per day – in Mexico, Venezuela and Brazil.

Note: The individuals that apply for Visas – know all about every aspect I am writing: the slaves, the forced sexual slavery. They shrug – often laugh at those that they believe beneath them.

Mass poverty and crimes are tools throughout the world – by those in power – to control their populations. Latin America never advanced into the modern era of civility. Latinos believe and practice "Elitism." Same as the

Indian immigrants – that still practice "The Cast" system in India, and likewise they bring their culture (beliefs) here, into the United States of America.

Latinos – and immigrants from India – take pride – not in doing the right thing – they take pride in their evil. They will brag, boast, about how corrupt their nations are – how there's slavery, mercenaries, mass corruption – and that is the culture that they came from. They believe this to be a trait – a quality that makes them stronger than Americans – and that is what they use and wield against our citizens. Thus, they believe themselves superior to Americans.

It – Latino culture – is a culture of evil – and not of Law & Order. It is completely against all that America stands for.

#### Mass Poverty in Latin America

The statistics on homelessness in Latin America – is a flat-out lie. There are literally millions of Latinos that have made – shanties – makeshift homes under overpasses, in the jungles near towns – on public property – on land they do not own. The statistics do not take into consideration these improvised domiciles – that which are not, nor can be owned by those that live within. Entire families starve to death in these humble shelters. City workers – walk through the squalor – once a week to identify the dead bodies – place them in bags, and carry them away, without notice – record or identification. Everything swept under the rug – out of mind – to be forgotten.

Approximately 80% of all Brazilians live in a state of poverty. They are not allowed to open bank accounts. They are not allowed to make minimum wage. They are not allowed to purchase land, to build their homes. But those are still the lucky ones.

Those that can't make it – are forced out of public life – onto the streets, and into destitution. They will not get work – in any capacity. They will be given a disease – forced to sleep near lepers, or people with elephantiasis, on the streets – thus be infected.

Yes. There are lepers in the major cities of Latin America – to this very day, and nobody takes care of them, or even gets them off the streets. And there are many with other diseases: In Brazil – there are 20,000 to 40,000 people with elephantiasis – many living on the streets. I have personally seen this with my own eyes. Entire families – dying – sleeping in bus stations – with limbs so cumbersome – weighing as much as 200 pounds – just an arm or leg.

Note: The statistic might be off – because these people die so quickly. They do not last very long, once they are forced on the streets, with this disease.

None of the immigrants that enter this nation from Latin America – care about these individuals. This is their culture. And those that apply for Visas to enter this nation – are those that created the living hell in their nations, and refused to fix the problems. These individuals come into the USA illegally – breaking our laws – then claim they need special treatment – they are the ones that are "Minorities," and get special treatment, and they are qual to African Americans – the descendants of slaves.

The enormous homeless epidemic in this nation – the United States of America – is specifically because we have allowed Latin American culture to grow and flourish – and not turned these immigrants into "Americans," that of Law & Order. They have formed their own communities – where total complete lawlessness dominates. No laws are abided – no taxes are paid. Their lawless culture becomes "The Norm," and society – law abiding civilization falls apart – collapses – and we let these immigrants tell us, how terrible we are...

#### **Review:**

Additional Notes/Reminders: A brief review of various crimes being committed against this nation – our people, by Mexico (the Mexican Mafia, and their associated gangs – all immigrants in this country illegally):

I have personally heard Mexican Mafia controlled – inmates – in jail – tell people how they smuggle drugs into our jails, and I've even heard them complain to the white inmates – that the other gangs – whites and blacks – don't smuggle drugs into jails – only the Mexican Mafia inmates do.

Police, Jail Guards, Border Patrol – are forced to allow drugs to be smuggled into the USA, and into our jails – to corrupt our judicial and penal systems. Cocaine is used to corrupt the upper-reaches of power – while fentanyl (a purely chemical based drug) is used for the lower classes and even to murder – certain people – not limited to celebrities.

Immigrant doctors (without licenses) are forced to do home (illicit) medical and dental procedures. The procedures have become a form of currency, to be bartered, within immigrant communities – in return for crimes committed against Americans, and our institutions.

Immigrant doctors (with licenses) are forced to commit Medicare and Medicaid fraud – and perform fake surgeries to defraud Medicare and Medicaid. I've heard Immigrant doctors discussing and even training newly arrived doctors how to steal from our medical assistance programs. They also must provide medical supplies from their clinics to the illicit homes where medical procedures are performed – and even perform illicit surgeries, as well.

Mexican Insurgents – are created and trained in Mexican jails – build hideouts and shelters in our suburbs, where they will spend and operate for years – harassing and committing endless crimes against American citizens. Often, to force Americans out of communities, so Latinos (illegal immigrants) may takeover. All other immigrants must assist, and hide these crimes, or suffer the consequences.

Immigrants refuse to pay taxes – while doing cash jobs – while collecting financial and medical assistance. Illegal immigrants that steal – will train and even force newly arrived immigrants to also steal from our institutions.

Example: Rogerio & Karina Pezini of Marietta, Georgia – who never paid taxes, and only worked cash jobs, and was even rewarded with illicit medical procedures (in homes) for protecting, and assisting illegal immigrants from Mexican and El Salvador, to commit various crimes against the nation they wish to immigrate to (USA).

These immigrants launder money out of the country – to invest and own property in the nation where they immigrated from. Then, after endless crimes against the USA – these immigrants are then rewarded for their crimes – by obtaining Green Cards and citizenship.

Example: Luis Carlos Valente of Boston, Massachusetts – who never paid taxes, and only worked cash jobs, and was even rewarded with illicit medical procedures (in homes) for protecting, and assisting illegal immigrants from Mexican and El Salvador, commit various heinous crimes against our citizens, this nation (the USA) where he wishes to immigrate to. He also has over \$100,000 worth of investments in his home country – from laundered money – of which he did not pay taxes for.

Mexico (thus, the Mexican Mafia and their various illegal immigrant alliances) take control of streets – to prevent American citizens from working cash jobs – that prevents Americans from lifting themselves out of poverty, after various issues in life – not limited to jail. The illegal immigrants create millions of homeless Americans. These immigrants are recreating the mass poverty in their culture – that they don't care about – nor

did they attempt to fix. They are – with other immigrates – refusing to become Americans – thus completely destroying our nation. Crime over crime – creating mass criminality – they don't pay taxes – nobody obtains licenses for businesses – there's no transparency – until everything – our American communities collapses – all must commit crimes to survive. Then, when all the cities have fallen (like New Mexico) the entire state, becomes a negative draw on our nation. This will continue to happen until this entire nation's economy – like that of all of Latin American nations – don't function. Men and women will be forced into slavery, and indentured servitude. Our entire way of life, will collapse.

Our nation, that fought and won 2 World Wars – while their cultures (with the exception of Brazil in WWII) did nothing... We freed Cuba, the Philippines (twice – from Spain, then Japan in WWII) Puerto Rico, Guam – we freed and created South Korea – are now expected to be quiet – and listen these immigrants claim to be victims – as they destroy our nation – and insult us in the process.

We are a diverse people – *that* prides ourselves on Law, Order & Justice – the world over – that which many want to immigrate to – to obtain self-respect – and we should not allow a culture – of lawlessness – that people are running from – to come here, and call us, "Evil," and or claim their culture – that refused to respect them as human beings – to be better – and thus undo our nation, with their lack of respect for that which we hold most sacred.
